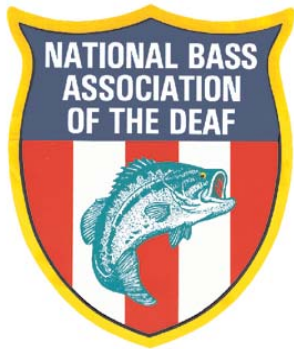

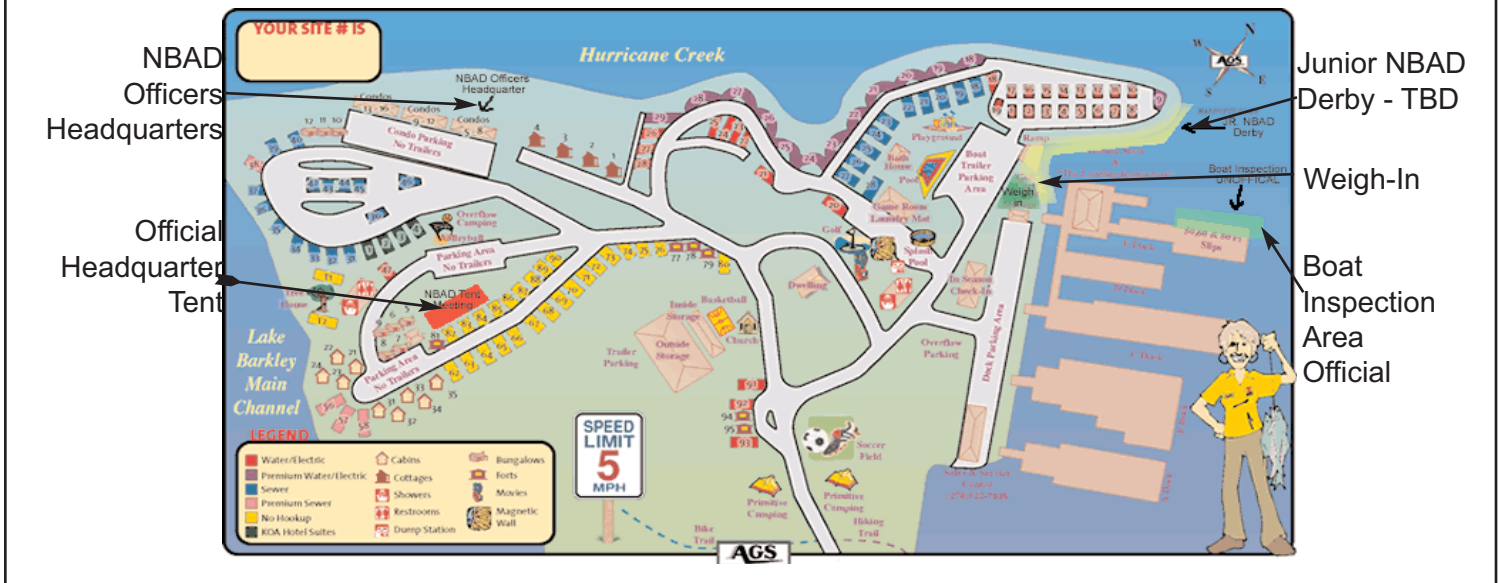
**Prize Purse is \$8,000 plus \$3,000 in daily prize.**

- The prize purse will go up as more participants are registered. It is \$8,000 before registration.
- Payout will go to top 25% of number of boats (1 to 4 ratio). If 100 boats, then payout to first 25 boats.
- Both host money and \$65 entry fee go to prize purse.
- There are **NO first place guarantee** without knowing how many boats that have signed up. NBAD will announce the number of registered participants in Monday General Meeting.
- The chart on the left is an example for 50 boats with \$65 entry per person or \$130 per boat and \$8,000 from the host.
