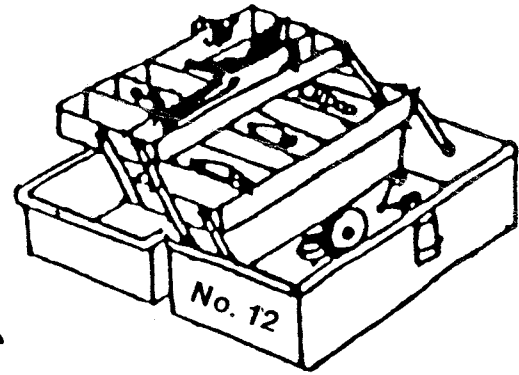

16th Annual NBAD Team Tournament Will be Held at Kentucky Lake on June 11, 12, 13, 1991 for Third Time

The 16th Annual NBAD Team Tournament will be held at Kentucky Lake at Benton, Ky. on June 11, 12, 13, 1991.

The headquarter site will be located at Sportsman's campground and marina. The tournament will be sponsored by Dayton Deaf Anglers Club with Phillip Seim as General Chairman.

It will be third time for Kentucky Lake as the tournament site since 1984.

Indiana Bass Association

of the Deaf hosted the NBAD annual team tournament at the same lake twice time in 1984 and 1987.

It will be interesting to see and find out how many of anglers participate at that lake and compare which year gets most. The first time it had 82 in 1984 and it was increased to 118 in 1987.

NBAD Urges Anglers to Consider and Vote for Western Site in 1997

A suggestion was made by Executive Board, Charles E. Marsh, Jr. that either NBAD Secretary or Publicity Director is to send out the information of opportunities of any western states region bass clubs to acknowledge their possibility of hosting 22nd or 1997 NBAD Team Tournament in their area with essential information on bidding guidelines as soon as possible.

The Publicity Director has an answer to Charles's suggestion if possible.

In 1988, at Truman Lake,

in Missouri, there was close vote on bidding for 1994 Team Tournament by between Missouri and California.

Elmo Hickerson, a representative for Sacramento Valley Silent Anglers, tried and worked hard to convince the anglers that Steele Park Resort at Lake Berryessa at Winter, California was appropriate site for NBAD tournament. However, his bidding failed him and Missouri won.

The Steele Park Resort has many features; Bait & Tackle shop, Gasoline, repairs, boat rental, RV park with hook-up, swimming, grocery store, lounge restaurants, 150 campsites, motel like a walking distance, 12 inches size minimum, 5 bass limit.

Well, it would be a good idea to suggest that Sacramento Valley Silent Anglers to have an honor of being the first western bass club to host NBAD Team Tournament in 1997 without bidding at the meeting this summer if the club is willing to accept to host the 1997 event.

If there is no bidding by any western bass clubs at the meeting to sponsor the 1997 Team Tournament, then the NBAD officers will have to take over the event.

How about this suggestion?

437 Anglers Participated in Tournaments Since 1976

The National Bass Association of the Deaf was founded by Robert E. Southwell of Texas and late Anthony Mowad of Louisiana in 1976. The first Annual Individual Tournament was held at Toledo Bend Reservoir at Pendleton Bridge Marina in Louisiana. The tournament was hosted by two clubs, Texas Bass Club of the Deaf and Louisiana

Bass Club of the Deaf.

Sixty-two anglers competed in the first event and Texas sent a large group of anglers, 40, while 15 persons from Louisiana attended.

Now, the NBAD reports that there are 437 anglers who competed in NBAD's annual tournaments one time or more since an inception in 1976.

In 1987, the 12th Annual NBAD Team Tournament, hosted by Indiana Bass Association of the Deaf, had 43 rookies, the largest number, participated. Toledo Bend Reservoir received the lowest number of rookies twice, 14, in 1979 and 1985. The average number of rookies per year is about 26.

Question & Answer about Weight Slip and Individual Label

The Publicity Director recently sent out copies of questions and answers on WEIGHT SLIP, TACKLE BOX NEWSLETTER and INDIVIDUAL LABEL to 19 affiliated bass clubs.

The NBAD has received only 7 replies from the clubs.

The majority of clubs have approved and enjoyed our new TACKLE BOX newsletter.

Here is the result of the votes on weight slip and individual label as follows below:

FOR WEIGHT SLIP

No. 1 receives 5
No. 2 receives 2

FOR INDIVIDUAL LABEL

Vote for = 4
Vote against = 3

Since there are only 4 votes for individual label and the NBAD considers some clubs, which did not vote, have given their silent

consent to the project.

The NBAD has decided it will try to use it this summer for a trial.

The reason for the project is to help speed of work by officers and committee during weight process. It will reduce repetition of asking anglers for boat numbers at every time.

The officer will instantly glance at labels and put down quickly before anglers give numbers of bass and weights only.

It would not hurt us if we try on that project, and we will always find out and learn if it works or not through an experiment.

You can not prove it won't work without a tryout!

Please remember that all competitors in World Olympic games, even in Deaf Games, have to wear numbers during competition.

3-B

Those above labels will be attached with safety pins on back side and anglers will wear them during tournament at all times.

The numbers and letters will start with 1-A and 1-B and goes thru to 75-A and 75-B depending on how many anglers participate in tournament at that time.

The numbers represent boat numbers while the letters represent the names of anglers in alphabetical order.

The size of labels is one inch long as exact as shown above.

President Speaks

I would like to inform you all that our family traveled and stopped at Badlands National Park and learned about the Golden Access Passport. Since we are deaf and they gave us cards for a lifetime admission permit in the National Parks. Golden Access Passport is issued without charge to any citizen of the United States medically determined to be blind or permanently disabled for purposes of receiving benefits under federal law. It shall entitle the permittee accompanying him/her where entry is by any means other than private or noncommercial vehicle to enter any entrance fee area of the national park system administered by the National Park Service. You all deaf people go to any place of National Parks and ask for the Golden Access Passport.

NBAD received the letter from Ranger Boats Manufacturing Company that they thanked you for proposal regarding NBAD and appreciated your interesting in their company and would like to assist NBAD; however, they just can't always afford to take advantage of all the offers they receive and hope you can understand their position.

National Fraternal Society of the Deaf agrees to pay NBAD the endorser fee of 35% (one time) for the NBAD members who join NFSD. For example - a member pays a yearly premium of approximately about \$150.00. When the yearly premium is paid, NFSD send 35% (\$150.00) which would be \$52.50 to NBAD and NBAD will send 35% (\$52.50) which would be \$18.38 to local bass club. NFSD agrees to provide the lunger bass prize for \$1,000.00 to the person who breaks record. John Cloy is setting his lunger record of 7 pounds and 11 ounces. Both fishermen in a boat MUST BE NFSD members in good standing and have at least \$5,000 permanent type insurance or at least \$10,000 term insurance.

NBAD will have the present for the Hall of Fame Awards at social hour on Tuesday, June 11st at 7 P.M. after announcement of the winners for 1-2-3- places and lunger.

MOTION IV: Treasurer Jack Stigers moved to amend the N.B.A.D. Constitution (By-Law) that the schedule of events is for announcement of the winners for 1-2-3 places and luncheon at 7:00 P.M. instead of 5:00 P.M. for Tuesday, Wednesday, and Thursday. Effective now.

Leroy Elmer, 1996 Chairman of W.D.A. will have the tournament at Truman Reservoir in Missouri.

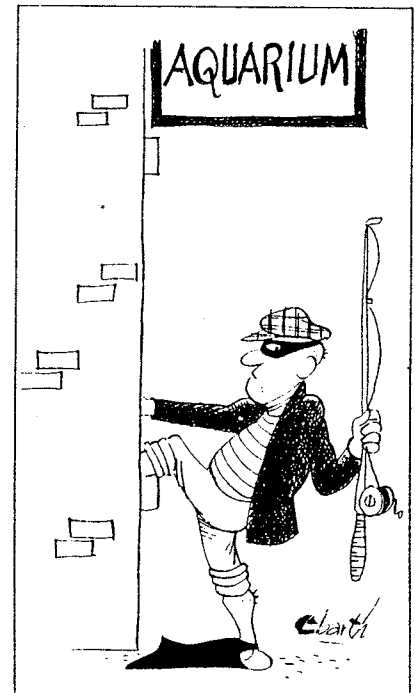
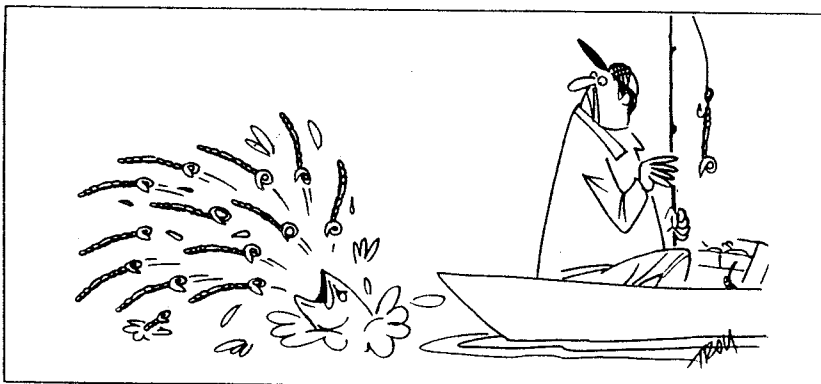
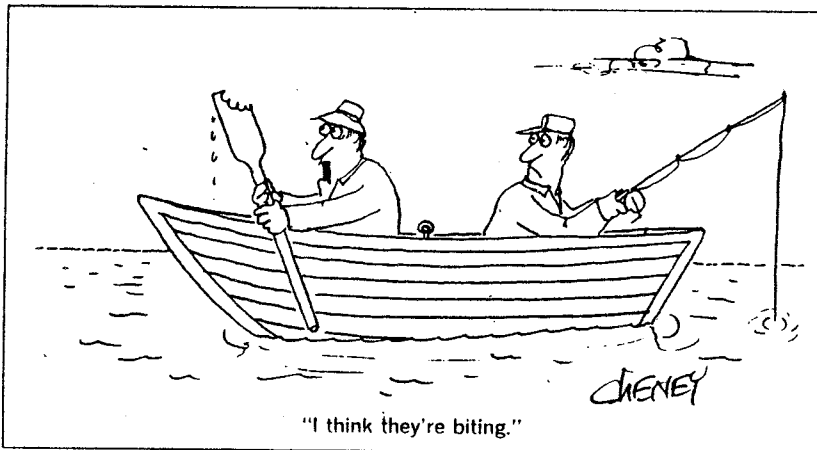
