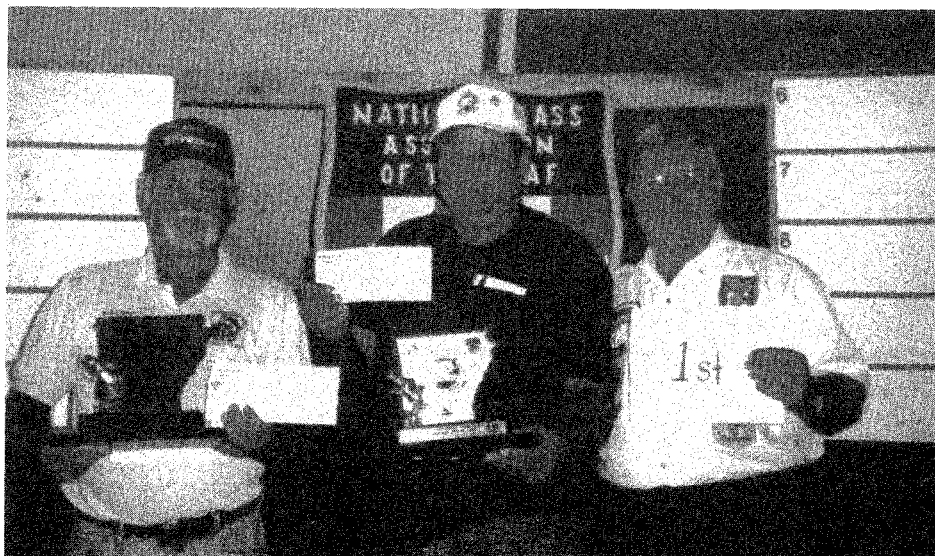

## 24<sup>th</sup> ANNUAL NBAD TEAM TOURNAMENT

June 15-17, 1999 at Lake Ouachita, Arkansas

This year’s team bass tournament was held in Arkansas at Lake Ouachita. The host was the Little Rock Bass Anglers of the Deaf (LRBAD), an affiliated club of the National Bass Association of the Deaf.

The winners of the \$5000 pot this year went to Keith James of Arkansas and Gene Amons of Louisiana. This was the 5<sup>th</sup> championship for Gene, but the 1<sup>st</sup> for Keith. The total team weigh-in for the three days was 20.8 pounds. They were in 2<sup>nd</sup> place on Tuesday with a total of 8.35#, in 1<sup>st</sup> place Wednesday with a total of 9.53#, and in 12<sup>th</sup> place Thursday with a total of 2.88#. The bad fishing on Thursday still gave them enough to keep their 1<sup>st</sup> place “overall” standing. But a good question – Were they worried while fishing that day about dropping in their rank?

# 24<sup>th</sup> ANNUAL NBAD TEAM TOURNAMENT

June 15-17, 1999 at Lake Ouachita, Arkansas

Lake Ouachita is located near Hot Springs, Arkansas. The host of this tournament was the Little Rock Bass Anglers of the Deaf (LRBAD). The chairperson from LRBAD was Rondale Ketchum. He and his committees did a wonderful job as host this year and led a successful tournament. NBAD officers thank all of them for the great job.

This year there were 184 paid entries. The anglers come from Arkansas, California, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, Louisiana, Maryland, Minnesota, Missouri, North Carolina, Ohio, Oklahoma, Tennessee, Texas, Virginia, West Virginia, and Wisconsin. The state with the most entries was Missouri with 32 entries. Arkansas, Indiana, and Tennessee each had 15 entries. We had 14 new anglers (Rookies) this year.

Tuesday was the worse day for most of the anglers with a total of 113 pounds being weighed in. Wednesday was the best day with a total of almost 150 pounds being weighed in. And on Thursday, the total weigh-in was almost 123 pounds, just a little better than Tuesday.

In first place were Keith James of Arkansas and Gene Amons of Louisiana, a winning team for the first time, although Gene had won before with other partners. Their story is on the front page.

In second place were Edward and Brett Ketchum of Arkansas. Rondale and Stanley Ketchum came in 4<sup>th</sup> place. The Arkansas anglers pretty much dominated the tournament this year! So they know the lake pretty well! Edward and Brett had a total of 18.2 pounds, just a two-pounder fish away from the first place. On Tuesday, Edward and Brett were in 3<sup>rd</sup> place with a total weight of 8.13#; on Wednesday they were in 4<sup>th</sup> place with a total weight of 7.35#; and like the champions on Thursday, they fell down the line to 14<sup>th</sup> place with a total weight of 2.68#. So, for a second place in the final totals, they did fare pretty good!

Third place went to Robert Turner of Georgia and his partner, James Amici of Florida. They had a total weigh-in of 15.1# for the three days. Their three days of fishing was a climb from a rank of 34<sup>th</sup> on Tuesday to the final 3<sup>rd</sup> place for the three days total. Tuesday was the "bummer" day as they had only one fish weighing .86#. Then on Wednesday they found the "gold mine" and had a total weight of 9.23# and come in 2<sup>nd</sup> place for the day. Finally on Thursday they did fair and placed 8<sup>th</sup> with a total weigh-in of 4.97#. So their "ups" and "downs" paid off pretty well.

The big fish Tuesday was 4.605# caught by Harry Sheffield of Kentucky; on Wednesday it was 5.04# caught by Kenneth Dornacker of Wisconsin; and on Thursday it was 4.02# caught by Steve Corbett of Missouri. So the winner of Big Fish (Lunker) award for the tournament was Kenneth Dornacker.
